

The 47th Annual Meeting of Shareholders of Huna Totem Corporation will be held on Saturday, June 19, 2021 in Juneau, AK via webcast. The Annual Meeting will be called to order at 2:00 p.m. for the following purposes:

- 1. Approval of minutes of the 46th Annual Meeting;
- 2. Election of three members to the Board of Directors, each to serve a 3-year term, which shall end in 2024 or when their successors have been elected and qualified; and
- 3. The transaction of any other business as may properly be noticed to come before the meeting and any adjournment thereof.

Only Shareholders of record at the close of business on April 28, 2021 are entitled to attend and/or vote at this meeting. Board Slate candidates, as approved by the Board of Directors are Ernest Jack, William B. Davis, and Theresa M. Belton.



To receive paperless communication, opt-in on your MyHunaTotem account.






Gatheeni Fills Gap in Ferry Service

The inaugural sailing of supplemental transportation service between Hoonah and Juneau on the Gatheeni, Icy Strait Point's 49-passenger catamaran, was conducted on March 12th. Although our vessel was not initially intended for ferry type service, the vessel and crew stepped in to provide a vital service to the community during the gap in Alaska Marine Highway System (AMHS) service, running a total of five (5) round-trips during the month. We were nearly full for each sailing and provided transportation for many people

during timeframes when planes were unable to fly. Hoonah residents were able to connect with family, attend to medical needs, stock household supplies – all continuing needs of an Alaska community. It was a new and exciting business venture for Icy Strait Point and our Marine Operations staff. We look forward to more opportunities to serve our community, and hopefully region, in the future.

Firewood Donated to City for Community Use

On November 24, 2020, ISP & HTC donated the logs from the wilderness landing clearing to the City of Hoonah. In partnership with the City, the wood was taken to subdivision road next to the clinic where the City of Hoonah gave back to the community by processing and making it available for personal use firewood. Hoonah families in need of firewood will be happy to hear that Icy Strait Point has donated an additional 40 logs that will again be processed and donated back to the community in conjunction with the City of Hoonah. Thank you to the many helpful hands that made this firwood program a success.



Collections Care for Access and Growth: A New Grant Funded Archives Project

Huna Heritage Foundation has done an excellent job of collecting cultural and historical records since the 1990's. We are excited to share that Huna Heritage has been awarded a 2-year grant from the Institute of Museum and Library Services to process our collection for access and use of the audio and video recordings, photographs and print material of Hoonah culture and history that are held in our archives. This project will fulfill the expressed need for archives access from our Hoonah people, Elders, students, and instructors; and those studying our cultural ways of being. While we work to provide maximum access to archival collections we also strive to steward and honor the integrity of culturally based items. As such, some materials may have legal, institutional, family, or clan restrictions to access some or parts of the collections. For example, access to cultural material may be accessible to our community members but not the general public.

A core program of HHF is the Library and Archives whose mission is to preserve material of historical and cultural value for the education and enjoyment of current and future generations. We understand and value the need to properly process our unique collections for the purposes of access, preservation, and education. By providing access to the stories and photographs of those who came before us, we build intergenerational connections. We are better able to share our way of life with our people by increasing accessibility to historical and cultural photographs and audio and film materials through arrangement, descriptions, and finding aids. This project supports community needs by providing access to stories, photos, cultural history, and our collective identity. Huna Totem conducted shareholder surveys, available to over 1400 shareholders in 2012 and 2019 to identify priorities. Shareholders indicated the preservation of culture through library, archives, and historic collections activities as the second highest priority behind higher education scholarships. The Collections Care for Access and Growth project is in direct response to the assessed shareholder and community needs and the growing interest in conveying traditional knowledge and Hoonah history.

The Executive Director and Board of Trustees wholeheartedly support the project as the next archives priority for HHF. Brett Dillingham is the Juneau based Archivist and has served Huna Heritage Foundation as digital archivist, audio interviewer and historian for the past three years. Michael Cheslock is the Hoonah based Project Coordinator and has served as the Film Project Coordinator for Huna Heritage Foundation for the past year and a half. The archives have provided material for Michael's short films and he has become aware of the overwhelming need to have the archives processed so shareholder access and use become a reality.
